- Fuel Flow is up, YTD 3.7%
- Rwy 6 EMAS still in permit phase. Scheduled to start this June.
- Rwy 1, safety area improvement including a patrol road
- Airfield lighting upgrade and all new runway signs
- Tree cutting & obstruction elimination
- Anticipate runway closures, and encourage use of Dalton 2 to minimize delays. (Pilots must request this departure by name.)

- Due to weather, TEB has been using North flow rather than South, so there have not been many requests for the Dalton 2.
- Controllers are getting familiar with new procedure.
- Compliance needs to be high.
- Discussed the difference between manual, individual and auto releases.
