- Rehabilitation of Stormwater Drainage Systems
  - o Multiple locations around the airport, airside and landside
- AIRPORT CLOSURES due to construction plan for 12-hour duration (Sundays 0000L 1200L)
  - $\circ~$  Between July 6, 2024, and Sept. 1, 2024
  - 5 7 work periods, late September, 1 additional 12-hour closure for final runway markings application








#### Average Number of Birds Observed per Survey






#### Average Number of Birds per Guild Observed per Survey








#### October 2023:


## Complaint Locations October 2023


Households within a 20-mile radius of TEB
