Welcome

Maria Sheridan welcomed everyone to the Teterboro Airport Manager's meeting and thanked everyone for attending.

Maria provided the following statistics report for October 2023:

Highest Activity Day: 700 operations on Thursday, November 9th

Days with operations over 600: 11 Over 700: 1

The airport had a total of 15,732 operations in November. The month to month comparison was unchanged compared last year. Year to date operations are up compared to this time last year. Fuel was up 3% for the month and 3% year to date. International arrivals were down 9% for the month but were up 1% year to date. The highest day for operations occurred on Thursday, November 9th when we had 700 movements. We had 11 days with over 600 movements and 1 day with over 700 movements.

Airport Operations Report

Scott Marsh provided an update on Airport Operations as summarized here:

- <u>Tenant Alteration Application (TCAP) Update</u>
 - In May 2023 the Port Authority transitioned from SharePoint to the e-Builder platform for electronic documentation submittals.
 - The following additional changes became effective in December:
 - Minor Works Applications will now be submitted in e-Builder.
 - The MBE-WBE-SDVOB PA form 3749D has been updated.
 - B2G Internal Memorandum PA form 3749D has been updated.

• FAA Construction Projects

- The following FAA projects are scheduled to take place starting April 22, 2024:
 - RWY 01 upgrade from a VASI to a PAPI
 - Power Distribution Upgrades To:
 - RWY 01 VASI upgraded to a PAPI
 - o RWY 01 REILs
 - RWY 06 LOC
 - **RWY 06 GS**
 - o RWY 24 PAPI
 - ASOS (Automated Weather System)
- Construction of new ATCT Control Tower
 - Construction is proceeding on schedule.
 - Commissioning of the new facility is expected to take place in the Fall of 2024.

• <u>2024 Airport Construction Projects</u>

- Runway 1/19 Rehabilitation
 - Mill and Pave, Upgrade Lighting System to LED
- Rehabilitation of Stormwater Drainage Systems
 - Multiple locations around the airport, airside, and landside
- 2024 Airport CLOSURES due to construction:
 - Closures of 12-hour duration (Sundays 0000L to 1200L) between July 6 & September 1, 2024.
 - 5-7 work periods, in late September one additional 12-hour closure will take place for final runway markings application

<u>Airport Operations - Traffic Outlook</u> –December 2023 and January & February 2024 Scott Marsh provided a list of upcoming events as follows:

The airport community is reminded to keep these events in mind and plan ahead in order to avoid congestion/gridlock. Operators are encouraged to work with FBOs to make sure facilities can accommodate arrival times and days.

Airport Security Update

Scott Marsh provided an update on security items as summarized here:

- <u>Community Watch Audit Update</u> 15 security audits were conducted in November with 106 items inspected. The Airport was fully compliant with zero findings.
- <u>Operations Ramp Access Request</u> Operations processed 119 ramp access requests.
- Operations Airport ID Checks Operations performed 144 ID sweeps with 100% compliance.
- <u>Enhanced Security Level</u> Enhanced security level remains in effect as a result of the war in the Middle East.

Snow Season Preparation

Brandon A'Hara provided an update on the 2023/2024 snow season as summarized here:

- Snow season started on October 15th and will run to April 15th
- Operations staff are fully prepared for the 2023/20324 snow season.
- We have had no snow events this year.

Wildlife Management Report

USDA Biologist Terri Riotto provided an update on wildlife management as summarized here:

Terri opened the presentation with a picture of a Red-tailed hawk who had a very interesting journey on the way to Teterboro. Terri captured this bird at the airport the first week of November. She found that the bird had been banded by the Raptor Trust (which is a bird rehabilitation center in Morris County). The bird was originally found in April in New Brunswick with a broken wing. It spent five months in rehabilitation at the Raptor Trust. It was subsequently released in September in Bridgewater and made its' way all the way to Teterboro where it was trapped and relocated under our Raptor Relocation Program. Let's hope this intrepid little guy continues safely on with his journey.

<u>Average Number of Birds Observed per Survey</u> – 20 birds per survey were observed compared to 17 in the historic average.

Average Number of Birds per Guild Observed per Survey - Observations consisted of mainly Blackbirds.

The Noise Office received a total of 5,678 noise complaints from 118 individual callers in November. 497 of these complaints came from 51 callers during the hours of 10:00PM to 7:00AM. Year to date we have had 65,521 complaints from 714 callers.

67% of all noise complaints were submitted by just two individuals. 69% of complaints were related to arrival traffic. 57% of complaints were submitted via 3rd party apps.

Overall, the number of complaints are down. Complaints during nighttime hours are also down compared to last year at this time.

Complaint by Community:

Complaints from households within a 5-mile radius came primarily from the areas of Hackensack, and Rutherford.

Complaints from households within a 20-mile radius came primary from northern upper Bergen County areas.

Noise Violations:

The airport issued 9 first time violation letters, 1 third violation (resulting in an aircraft being banned from utilizing the airport), and 2 warning letters. Year to date 72 first time violations, 2 second time violations, 1 third violation and 25 warnings have been issued.
